Accredited and reputed foreign companies are exempted from this condition according to the provisions of item (First/ B) of article (4) of the Law of Executing Governmental Contracts number (2) of 2014.

Biddings shall be submitted in closed and sealed envelope to our embassy in Paris whose address is mentioned above on (Wednesday), 12:00 p.m. the 12/4/2017, and a receipt will be given to confirm the receiving envelopes with an expiration period not less than 180 days starting from date of tender closure. We would like to inform you that a conference will be held at our embassy in Paris on (Monday) 12:00 p.m. the 3/4/2017, to answers any questions and queries by the applicant companies.

The biddings will be opened by the Tender Opening Committee at the same day of tender closure.
