2. The requisite qualification requirements (**Supplying TOOLS and Equipments**).
3. Interested bidders can buy bid documents , after submitting written request addressed to ministry of defence / general directorate of contracts and sales , after paying amount (100.000) Iraqi dinars
4. The bids are delivered to the following address (Baghdad- karada Merriam near al-Jamhuriya Bridge / entrance of green zone) at the specified date up to **(1200 of Monday August, 2017 )** late bids will be rejected, and the bids will be opened by the attendance of the bidders or their representatives. at the ABOVE MENTIONED ADDRESS and at time **(1300 of Monday 21<sup>st</sup> August, 2017 )**.
5. Advertisement's duration shall be on **Monday 24<sup>th</sup> JULY UP TO 21<sup>st</sup> August 2017**.
6. The total estimated cost: (**\$ 1.222.810**) million, two hundred twenty- two thousand and eight hundred and ten USD.
7. **Wanted country of origin: Danmark, Germany, America, Japan, China**
8. the supplying period : **90 days**
9. The good performance bond that equals to (5%) of the total contract's amount shall be submitted after awarding prior to signing contract .it must be unconditional and payable on request issued by government bank or accredited bank to the central Iraqi bank as for (Iraqi companies and foreign companies hat have representation in Iraq) and a bank accredited by trade bank of Iraq (TBI ) as for foreign companies that don't have representation in Iraq.
10. To submit a non – objection letter to participate in tenders issued by General Commission of Taxes as for local companies and( foreign that have representation in Iraq) addressed to ministry of defence with taxes identity and number.
11. Iraqi & representation's bureau of foreign companies in Iraq must submit a letter of discharge issued by Retirement and Social Security Office.
12. To submit stamp's fee (**0.003**) of the contract's amount at the same contract's currency as per act. # 71 of 2012 and (**0.001** ) of contract's amount as per judicial fee on condition not to exceed (10.000) Iraqi dinars according to (act # 11 of 2015).

13. Iraqi and foreign companies must submit their financial statements of the last two years. least . Iraqi and foreign companies which have a bureau of representation have to submit a letter issued by Accountants Corporation certifying the legal situation of the accountant who submit the final accounts within the documents of them .
14. Bidders should submit a letter issued by ministry of planning showing that they are not in the black list and the blocked Israel companies.( that is for Iraqi companies and foreign companies that have a representation in Iraq).
15. To write unit prices and total ( in handwriting or printed in digits & in writing)
16. Written prices shall be based when differs of digits.
17. Evaluation shall be conducted using:
  - 1 -no deviation in supply items
  - 2 - The quick supplying.
  - 3- Compatibility to required specifications.
  - 4-competitive quotations.
18. To submit a list of achieved similar works certified by contracting entities.
19. First party has the right to deduct any debts (if there is any) of second party' payments.
20. Contract shall be subject to all Iraqi valid acts even the Income Taxes Law # 113 of 1982 and its instructions and amendments.
21. The winner shall bear the fees of the advertisement of the last time.
22. No scrape or amendment in the tender's documents shall be accepted.
23. If many bidders take part in one tender. Their contract's partnership must be submitted
